JESSE BROWN VETERANS AFFAIRS MEDICAL CENTER

General

Jesse Brown Veterans Affairs Medical Center (JBVAMC) is one of seven VA health care facilities comprising the Veterans Integrated Service Network 12 (VISN 12). The other six VA facilities are: Hines VA Hospital, located in Hines, Illinois; Iron Mountain VAMC located in Iron Mountain, Michigan; Madison VAMC, located in Madison, Wisconsin; Milwaukee VAMC, located in Milwaukee, Wisconsin; North Chicago VAMC, located in North Chicago, Illinois; and Tomah VAMC, located in Tomah, Wisconsin.

In June 1996 the two Chicago-VA Medical Centers – Lakeside and Chicago West Side – were integrated under a single management structure and named the VA Chicago Health Care System. Prior to the merger and since they were originally opened in the early and middle 1950s, the two hospitals had been operating as independent tertiary care medical centers. In August 2003, Chicago Lakeside inpatient services were discontinued and all JBVAMC inpatients are now treated at the former Chicago West Side. In May 2004, the VA Chicago Health Care System was renamed the Jesse Brown VA Medical Center.

JBVAMC is a tertiary care medical center that annually provides care to 43,200 veterans, most of whom reside in Cook County, Illinois and Lake County, Indiana. The medical center now has 178 inpatient operating hospital beds and in fiscal year 2013 treated approximately 6,900 inpatients and accommodated approximately 612,000 outpatient visits. JBVAMC operates four community based outpatient clinics: Lakeside at 333 E. Huron, Chicago, Illinois; Adam Benjamin, Jr. in Crown Point, Indiana; Chicago Heights in Chicago Heights, Illinois; and Auburn-Gresham, on the southside of Chicago, Illinois. As of the date of this Official Statement, JBVAMC's main campus had approximately 2,422 full-time employees and 200 regularly scheduled volunteers, and an annual budget of \$363,549,470 for the Department's fiscal year ending September 30, 2013.

The University of Illinois at Chicago – College of Medicine and Northwestern University's Feinberg School of Medicine are JBVAMC's primary academic affiliates.

Mission

The mission of JBVAMC is to serve America's veterans and their families with dignity and compassion and to be their principal advocate in ensuring that they receive the care, support and recognition earned in service to this nation.
