The Green Bonds

On January 5, 2016, the San Diego Unified School District (the "District") issued \$100,000,000 SAN DIEGO UNIFIED SCHOOL DISTRICT 2016 General Obligation Bonds (Dedicated Unlimited *Ad Valorem* Property Tax Bonds) (Election of 2012, Series G) (Green Bonds) (the "Series G Bonds" or the "Green Bonds"). As of February 1, 2017, the District expended approximately \$1.9 million on green projects and has committed approximately \$24.5 million in green projects. The District has several projects being awarded in the coming months that have eligible green bond scope.
