Rating Action: Moody's downgrades enhanced ratings of various PA issuers

New York, July 22, 2014 -- Moody's Investors Service has downgraded the enhanced ratings on various Pennsylvania issuers (see below). These actions follow the downgrade to Aa3 from Aa2 of the Commonwealth of Pennsylvania's GO rating. The outlooks vary by issuer (see link below).

SUMMARY RATING RATIONALE

The downgrades apply to select enhanced ratings associated with the Pennsylvania Act 150 School District Intercept Program, Pennsylvania School District Fiscal Agent Agreement Intercept Program (Sec. 633), and State Public School Building Authority Lease Revenue Intercept Program. These actions follow the downgrade to Aa3 from Aa2 of the Commonwealth of Pennsylvania's GO rating.

The enhanced ratings reflect Moody's assessment of each issuer participating in the programs pursuant to the methodology, "State Aid Intercept Programs and Financings: Pre and Post Default." Credit considerations include availability of funds, timing of state aid payments, state aid trend, strength of notification requirement, and timing between notification and intercept. Additional credit factors include a debt service coverage ratio and the underlying ratings of the individual school districts.
