ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Olympic Educational Service District No. 114 for the period from September 1, 2008, through August 31, 2009.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Cash receipting
- Small and attractive assets such as computers
- Insurance/risk management
- Open public meetings/records laws
- Budget compliance

- Disbursements/expenditures
- Payroll/personnel
- Compliance with grant requirements
- Educational Service Districts indirect costs

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

Description of the District

ABOUT THE DISTRICT

Olympic Educational Service District No.114 was established to provide equity in educational opportunities and to ensure compliance with state rules and programs established by the Legislature, State Board of Education and Office of Superintendent of Public Instruction. The District provides technical assistance to local school districts and collects and reports information for accountability and funding purposes. As a member and manager of the Western Regional Data Center, a data processing cooperative, the District provides financial and student records services to 22 school districts.

The District provides services in Kitsap, Mason, Jefferson and Clallam counties. It offers numerous educational programs, which include Special Education, Head Start, the Kitsap and Clallam County detention schools, instructional materials cooperative staff and staff development for teachers. In particular, the District has taken a leadership role in adopting a comprehensive approach to youth substance abuse and treatment counseling. It has also developed a program under the Workforce Investment Act (WIA) for youth to attain basic skills, work readiness or occupational skills and secondary diplomas or other credentials.

The District has a seven-member Board of Directors. Board Members represent geographical regions and are elected at large by members of local school boards. The District has approximately 405 employees, including approximately 190 regular and 215 part-time and temporary staff. The WIA program temporarily expanded the part-time employees in the summer of 2009. The District's 2009 General Fund operating budget was approximately \$16 million.

In addition, the District administers and functions as a member of two insurance cooperatives and provides financial reports for these component units; the Workers' Compensation Trust and the Unemployment Insurance Compensation Cooperative.

The District's mission is to provide services to the local districts, to assist the Superintendent of Public Instruction and the State Board of Education in the performance of their duties and to promote equity in educational opportunity for students throughout the region.
