

### Scripps Health Obligated Group Fiscal Year Ended September 30, 2015

### Organization Structure

Scripps Health is currently the sole Member of the "Obligated Group" created pursuant to an Amended and Restated Master of Indenture dated as May 1, 1998 and supplemented through February 1, 2012 (indenture), between Scripps Health and The Bank of New York Mellon Trust Company, N.A., as successor master trustee. Scripps Health is comprised of multiple operating divisions that are not separately incorporated, including: Scripps Clinic, Scripps Green Hospital, Scripps Memorial Hospital La Jolla, Scripps Memorial Hospital Encinitas, Scripps Mercy Hospital (San Diego and Chula Vista campuses) and other business units. The Scripps Whittier Diabetes Institute, a not-for-profit public benefit corporation formed to provide research, education, and patient care in the field of diabetes, was merged into Scripps Health effective November 2011.

The following related entities, which are each separately incorporated, are not Members of the Obligated Group: Scripps Health Plan Services, Inc., Scripps Hospice, Gluck Child Care Center, and Imaging Healthcare Specialists. Scripps Health contracts for professional service with the Scripps Clinic Medical Group, Inc., Scripps Coastal Medical Group, Scripps Cardiovascular and Thoracic Medical Group, and Scripps Health Inpatient Providers Medical Group.
